PKC Elite Society - エリート — Nominee Qualifications

- **Must be a PKC member for a minimum of ten (10) years and five (5) years in Adult Black Belt**
- **Must be a PKC Lifetime member.**
- **Must have considerable knowledge of Keeney History , PKC History and the origin & essence of the PKC Elite Society**
- **Must NOT have any felony on record, and must NOT have a history of acts of violence or mental instability**
- **Nominee should have a consistent record of excelling in National level competition**
- **Must excel as a National level Black Belt competitor**
- **(Local Champions are only “Local Champions”)**
- **Must have a recommendation from current PKC Elite member**
- **Must receive a minimum 75% of voting body at meeting during PKC Internationals weekend**

Nominees will appear before the PKC Elite Society at the PKC International Championships, where society members in attendance will vote on possible candidate inductions. A seventy-five percent (75%) majority is required for induction.

PKC Elite Society - Nominee Considerations

- **Has this individual met the basic requirements to be worthy of review by this society?**
- **Has this individual done the things necessary, as a competitor and/or an ambassador to make themselves worthy of being in the PKC Elite Society?**
- **Please be reminded that this is not about whether you like a person or not, but whether this individual can and will be an asset for the future of the PKC and the PKC Elite Society.**
- **We will limit the number of questions that you can ask an individual to two, and these questions should reflect only your interest and revealing whether or not this individual has a competitive resume, and or the leadership skills to be an excellent ambassador for the PKC, and how valuable and worthy they will be as a member of the PKC Elite Society.**
- **Decisions about an individual should not be made on your personal feelings about them, or whether or not they attended an event you have held, but instead should be based upon their value to the PKC now and in the future by being accepted.**
- **Please provide the fairest assessment for each individual considered for admission into the PKC Elite Society.**
